IMPORTANT:

1. This result is provisional and is being declared on the basis of information filled by the candidates in their Online Registration Form and subsequently they were provisionally permitted to appear in the online (CBT) mode Recruitment Examination without screening their Online Registration Form. The candidates are advised to download their Verification Letter on the website using their login credentials.
3. The Category candidates who have claimed any relaxation as applicable to the particular category are placed in merit of their respective category. The candidate has been indicated by (*) in rank column.

4. The Candidature of OBC (NCL) candidates shall be subject to following:-
- (i) The certificate declaring the candidates as "OBC with Non-Creamy Layer" shall not have to be more than 6 months old.
 - (ii) The certificate has to be strictly according to the format prescribed by the DOP&T vide their office Memorandum No. 36036/2/2013-Estt.(Res.) dated 30.05.2014.
 - (iii) The certificate has to clearly mention the caste/sub-caste included in the Central list of OBCs.
