**NOTICE FOR PWBD CANDIDATES OF AIIMS PG ENTRANCE EXAM FOR
JANUARY 2019 SESSION**

With reference to the letter No.V-16020/144/2016-INI-I dated 26th September, 2018 of the Ministry of Health & Family Welfare, Govt. of India, the following guidelines is being circulated for the benefit of persons with benchmark disability:

1. In case of persons with benchmark disabilities in the category of blindness, locomotor disability (both arm affected-BA) and cerebral palsy, the facility of scribe shall be allowed, if so desired by the candidates.
2. In case of other category of persons with benchmark disability provision of scribe may be allowed to the effect that the person concerned has physical limitation to click/operate the mouse for computer based test (CBT) entrance examination.
3. All eligible PWBD category candidates (AIIMS-PG January 2019 session) desirous to avail the above mentioned facility are hereby advised to send their request by email to aiims.pgexams@gmail.com between 13.11.2018 to 15.11.2018 (up to 5.00 p.m.) through their registered Email ID. The email should be sent by registered email with a scanned copy of Admit Card, Certificate of Disability and Letter of Undertaking for using own scribe (Annexure 1). The facility for availing scribe shall be subject to scrutiny of the disability certificate by the competent authority of AIIMS, New Delhi.
4. The Original Annexure should be produced at the time of Examination.
5. In case there is no response within stipulated time, it will be assumed that the candidate is not desirous of availing the services of scribe.
