The details of vacant seat position (may change at the time of counselling) for Open round of counselling.

At the time of counselling candidates should bring all Original certificates along with one set of photocopies.

Failure to bring original certificate will make candidate ineligible for allotment of seat in the counselling.

Counselling will be done strictly in order of merit.

All candidate who are eligible for counselling must attend the counselling in person.

1. First and foremost, the UR counselling will be conducted and once it is over, the counselling for OBC category will be conducted and subsequently for that of SC/ST will be held.
2. If any OBC Seat remain vacant after counselling for OBC seat, all vacant seat will be transferred to UR category and will be offered to UR candidates on merit.
3. However, in case of SC/ST counselling, if any, SC seat(S) remains vacant, these will be converted to ST seat and vice versa. Finally, if any SC/ST seat remains vacant after the conversion has been done, then such seats will be converted to UR Category.
4. Hence, the UR candidate will be called again for counselling if any OBC, SC and ST seats remain vacant. It is advisable for all the UR category candidates who have not been allotted a seat in the first round should stay till the end of the counselling process.
5. In case a candidate is pursuing any other course or have opted for a seat in any other AIIMS, are requested to bring a proof of their resignation letter/seat surrender letter in original. If any fail to present the proof, they will be unable to attend the Open-Round Counselling.
6. All the candidates allotted seats must give an undertaking that they are not holding seat in any medical college. Failure to bring original certificate resignation/seat surrender letter as applicable will make candidate ineligible for allotment of seat in the counselling.
7. **No transfer of institution is allowed** in open counselling.
8. The OBC candidates who could not produce valid Central Govt. Institution/Job certificate in the **first three rounds of counselling and were declared not eligible will be allowed to appear in the counseling** subject to production only of valid OBC certificate issued for Central Govt. Institution/Job only. Failure to bring valid caste certificate shall make the candidates ineligible for the purpose of allotment of seat. No provisional allotment will be made.
9. If any candidate feels that he/she is eligible but his/her name is not in the list can come on the day of counselling along with documents in Original. However, He/she will be allowed to appear in counselling for allotment of seat only after verification of his/her claim of eligibility
