2. Conditional quotations will not be considered for acceptance.

3. The quotation(s), duly sealed, as per specifications mentioned above should reach the Examination Section, AIIMS, Ansari Nagar, New Delhi -110 029 on or before 13th May, 2013 upto 03:00PM. The tenders will be opened at 04:00 PM on 13th May, 2013.

- PART – II :- PRICE BID/FINANCIAL BID IN ONE SEALED COVER

TERMS & CONDITIONS

1. Turnover should not be less than the 70 Lakhs per year during the last three years.
2. The vendor will have to get the sample approved by the Examination Section, before supply of the required material.
3. The pens are required to be supplied duly packed to the Examination Section, AIIMS, as per specification within 15-20 days after placement of supply order.
4. The bidder submitting tender would be considered to have accepted all the terms and conditions. No inquires either verbal or written shall be entertained in this regard having effect on the contract.
5. **The bidder is required to submit the tender duly signed and stamped on all pages.**
6. **The bidder is required to quote their rates on Schedule-C provided with the tender.**
7. Tender document by Tele-fax/telegram/fax/e-mail will not be accepted.
8. Rates should be quoted strictly as per the specifications.
9. If the bidder provide false statements on any information, their quotation/tender will not be considered and it shall be deemed to have been rejected.
10. The Institute shall have the right to reject any quotation without assigning any reason thereof. No correspondence will be entertained in this regard.
11. Rates for only the best quality ball pen (as per our specifications) should be quoted. On no account rates of different qualities i.e. A,B, C & D should be quoted. The items that have been quoted as per different qualities (in contravention to the specifications) will not be considered at all.
12. One sample of Ball Pen as per specification should be submitted with Techno-Comm. Bid.
13. The tenders/quotations received without sample will be summarily rejected and no correspondence will be entertained in this regard.
14. Selection will be made purely on the basis of the sample vis-a-vis specification and terms & conditions of tender.
15. Quotations received after the last date of submission or without adhering to the above instructions will be outrightly rejected.
16. In case of delay in supplying the material as per specifications and Terms & Conditions within the stipulated time limit, 5% of the amount from the bill will be deducted as penalty for first time. If delay is one week for the delay beyond 7 days. The security amount will be forfeited and decision of Sub-Dean (Exams) in this regard will be binding & final.
17. In case the lowest quote does not fulfil the terms and conditions of the rate inquiry. AIIMS reserves the right to reject/cancel the supply order and award it to the next lowest quote at the rates quoted by the first lowest quottee.
18. Charges for packing & delivery will be included in cost of pen.
19. The bidder shall be manufacturer of pen.
20. The successful Tenderer shall furnish the Performance Security within 15 days of issue of Award Letter for due performance of the contract. The Performance Security should be for an amount of Rs.10,000/- (Rupees Ten thousand only) payable in the shape of FDR/Bank Guarantee from any Nationalized Bank in favour of Director, AIIMS, New Delhi and it shall be valid for 26th month from the date of issue of Rate Contract, failing to furnish performance security in time would entail cancellation of the contract and removal of name of the firm from the list of contractors.
21. TIN/VAT/PAN/Service Tax certificate shall be submitted with the technical commercial bid.
22. The price charged for the said service, under reference, by the supplier shall in no case exceed the lowest price at which the supplier provide the services of same identical description to any other person/organization/Institution during the currency of the contract as per fall clause adhered by D.G.S. & D. if at any time, during the said period the approved vendor reduces the said prices of such service to any other person/organization/Govt. Institution /Co. Operative Store at price lower than the quoted price, he shall forthwith notify such reduction to the Director, All India Institute of Medical Sciences and the charges payable for said services after the date of coming into force of such reduction shall stand correspondingly reduced and should attach an undertaking on affidavit as per enclosed format, otherwise quotation shall be summarily rejected.
